PREAMBLE:

St. Gonsalo College of Education, No. 2A, Dhanalakshmi Enclave, 38/40, North Boag Road, T. Nagar, Chennai-600017, Tamilnadu had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for B.Ed(Secondary) course on 30.12.2004.

In obedience to the directions passed by the Hon'ble High Court of Madras in W.P. No. 9423 of 2005 NCTE caused inspection of the institution on 20.9.2005. The inspection report and other documents furnished by the institution was placed before 101st SRC meeting held on 6th October, 2005 and SRC decided to issue notice to the institution under section 14(3)(b) of NCTE Act pointing out certain deficiencies. Accordingly a notice was issued to the institution on 9.11.2005 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

The institution has submitted the written representation on 28.11.2005 was considered by the Regional Committee in its 106th meeting held on 15-16th December, 2005 and decided to reject the proposal. Accordingly a rejection order was issued on 4.1.2006.

Aggrieved by the rejection order passed by SRC-NCTE the institution preferred an appeal dated 5.7.2006 to NCTE-Hqrs., New Delhi. Appellate Authority, New Delhi vide their order No. F.No. 89-107/2006-Appeal dated 26.9.2006 decided to reverse the order appealed against. The Appellate Authority order was placed before SRC in its 119th meeting held on 14th, 15th and 18th October, 2006 and SRC decided to accord recognition for B.Ed. course with an intake of 100 from the academic session 2006-2007.

Hence the order.

ORDER

In terms of Section 14(1) of the NCTE Act, 1993 **St. Gonsalo College of Education, No. 2A, Dhanalakshmi Enclave, 38/40, North Boag Road, T. 2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
 - a. The institution has acquired the land for setting up the teacher education institution.
 - b. The institution has constructed the building for conducting the course on the above mentioned land.
 - c. The institution has created an Endowment Fund of Rs.5 lakhs and a Reserve Fund of Rs. 3 Lakhs.
 - d. The institution has selected the **Principal and Seven** lecturers for the said course and the list of faculty members has been approved by the affiliating University.


3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to **St. Gonsalo College of Education, No. 2A, Dhanalakshmi Enclave, 38/40, North Boag Road, T. Nagar, Chennai-600017, Tamilnadu** for **Secondary(B.Ed)** course of **one year** duration from the academic session **2006-2007** with an annual intake of **100** students subject to fulfillment of the following.
 - a. The institution will ensure that **Principal and Seven** faculty members duly approved by affiliating University are in position for an intake of **100** students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case not later than one month from the date of commencement of the course.
 - b. The institution shall, within one month of the receipt of recognition order, convert the Endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
 - c. The institution shall shift to its own premises / building within three years from the date of recognition. (in case the course is started in rented premises)
 - d. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the affiliating University, UGC, State Government etc.
5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act, 1993.
